1. ANNOUNCEMENT AND JURISDICTION

The Wirral Hundred Motor Club will hold a Pre-Season Test Day at Oulton Park, Little Budworth, Tarporley, Cheshire on Friday 23rd April, 2021, under the above Permit granted by the ACU. The Meeting is held under the National Sporting Code and Standing Regulations for Road Races (Section 21 – Organisation of Test Days), these Supplementary Regulations, together with any Final Instructions subsequently issued or Official Announcements made.

3. RIDER & MACHINE ELIGIBILITY

1. All participants must be Registered Members of Clubs affiliated to the Cheshire & North Wales Centre ACU (Wirrral Hundred membership, if required - £20)

To be eligible to take part in this event all riders and passengers must be in possession of a current ACU, SACU or other FIM European affiliated FMN Competition Licence for Road Racing.

Holders of national licences issued by a European FMN other than the ACU or SACU must have start permission, that confirms the rider has Medical and Repatriation Insurance, from their Licence issuing Federation.

This include MCUI Licence holders

(Please hand a hard copy of the Start Permission to the Secretary of the Meeting at Signing On).

- For all riders under 18 years of age a completed Parental Consent Form must be produced before participation.
- Each rider is responsible for ensuring that both his machine and equipment comply with the Standing Regulations for Road Racing.

4. ENTRIES

Entries must be made on the Official Form and sent in advance to the Secretary of the Meeting:

5. ENTRY FEES AND INSURANCE

(1) Entry Fee - £145, payable in advance

The organisers undertake to insure each rider and passenger, indemnifying him against third party claims made arising out of the Test Day, excluding claims by other riders or passengers, entrants, sponsors or mechanics.

(2) Unless sufficient entries are received the Promoters may cancel the event. Any part or the whole of the Meeting may be abandoned should circumstances arise which in the opinion of the Promoters render such course desirable.

6. THE COURSE

The course is **2.692** miles to the lap. Race Direction will be clockwise. Maximum number of starters in any one session: solos 60; sidecars 45.

7. PROGRAMME OF EVENTS

Depending on the number of participants testing will be organised into five groups and it is planned that each group will have four sessions of 18 minutes each. The first session will start at **9am**.

Signing-on will be from **7.30am**
