3. RIDER & MACHINE ELIGIBILITY

1. All participants must be Registered Members of Clubs affiliated to the Cheshire & North Wales Centre ACU (Wirral Hundred membership, if required - £15)

To be eligible to take part in this competition all riders and passengers must be in possession of a current ACU, SACU or other FIM European affiliated FMN Competition Licence for Road Racing.

Holders of licences issued by any FMN other than the ACU or the SACU must have insurance and start permission from the relevant FMN. This includes MCUI Licenceholders.

This insurance must include the FIM Standard Repatriation.

2. For all riders under 18 years of age a completed Parental Consent Form must be produced before participation.

3. Each rider is responsible for ensuring that both his machine and equipment comply with the Standing Regulations for Road Racing.

3. ELIGIBILITY

All Competitors must be Registered Members of Clubs affiliated to the Cheshire & North Wales Centre ACU, or for the August meeting only registered to compete in the British ACU/FSRA F2 Sidecar Championship. (Wirral Hundred Membership if required - £15)

To be eligible to take part in these competitions all riders and passengers must be in possession of a current ACU, SACU or other FIM European affiliated FMN Competition Licence for Road Racing.

Holders of licences issued by any FMN other than the ACU or the SACU must have insurance and start permission from the relevant FMN. This includes MCUI Licenceholders.

This insurance must include the FIM Standard Repatriation.

4. ENTRIES

If there are insufficient vacancies to enable a reserve to ride he will have his entry fee refunded. Reserves will be accepted at the discretion of the organisers.

5. ENTRY FEES AND INSURANCE PREMIUM

(1) **Race Meetings** as per each Entry Form

The organisers undertake to insure each driver and passenger, indemnifying him against any third party claims made arising out of the races or official practice, excluding claims by other drivers or passengers, entrants, sponsors or mechanics.

(2) Unless sufficient entries are received the Promoters may cancel the event. Any event or the whole of the Meeting may be abandoned should circumstances arise which in the opinion of the Promoters render such course desirable. Only in exceptional circumstances affecting a particular rider will entry fees (less an administration charge of **£15.00**) be refunded – no refunds will be considered unless the Secretary of the Meeting is notified in writing at least two days prior to the meeting and the entry passes returned therewith.

6. THE COURSE

The 'Coastal' Course (1.55 miles) will be used for the March, 22nd June and August meetings and the 'International' Course (2.10 miles) for 23rd June and the October meetings.

Race direction will be Clockwise. Maximum number of starters: Solos 40 (practice 60); Sidecars 30 (practice 45).

7. PROGRAMME OF EVENTS

Class A - 100 - 500cc Allcomers

Class B - 650 Twins

Class C - Powerbikes (over 700cc, post 2008)

Class D - Pre-Electronics Powerbikes to 2008
(including Golden Era Superbikes)

Class E - Formula 600

Depending on the level of entries for each class, heats and finals may be run, further details in the Final Instructions. Classes may also be amalgamated. The race lengths will depend on the number of entries received. However it is planned that each of the classes A - I will have a minimum of two races per day.

Those entering classes K & L will have one additional race per day.

The criteria for Pre-Electronics Powerbikes and Forgotten & Golden Era machines, are available on the club website and on request from the Secretary of the Meeting.

8. AWARDS ON THE DAY

Awards in the form of cups or plaques will be given for either one or two specified races for each class at each meeting. The number of awards will depend on the numbers in each class.

Awards for the Earlystocks, FSRA Preinjection sidecars, ACU/FSRA F2 Sidecars. will be in accordance with their Championship conditions.

9. The WIRRAL HUNDRED MOTOR CLUB CHAMPIONSHIPS 2019

Points system: 15 - 12 - 10 - 9 - 8 - 7 - 6 - 5 - 4 - 3 - 2 - 1.

Ties to be decided by most wins, most seconds, etc.

All 'class' races at our meetings at Anglesey and Oulton Park to count.

Annual awards to at least the first three in each class, provided the entry levels justify this.

10. REPORTING

Technical Verification will commence at 8.00am. Riders will not be permitted to practice until their machine and protective clothing have been passed by a Technical Official. Riders and passengers must sign on with the Secretary of the Meeting before 10.00am after technical verification and before commencing practice.

Licences must be produced when signing on and any rider or passenger unable to produce his/her licence will only be permitted to start at the discretion of the Stewards in a meeting and may be liable to a fine not exceeding £10.00.

11. TRANSPONDERS

All machines must be fitted with a MyLaps X2, Tran X260 Transponder or equivalent.

12. PRACTICE

Practice will be of 15 minute sessions.

The timetable and order of practice will be in the Final Instructions, being determined by the entries received.

13. GRID POSITIONS

Grid positions for the first round of races will be determined, where possible, by timed practice. If rider numbers and practice scheduling prevent this, grid positions will be determined by a combination of championship positions, known ability and ballot.

The grid positions for the remaining races will broadly be performance-based, and will be as set out in the Final Instructions.

(August only - Grid positions for the ACU/FSRA F2 Sidecars will be in accordance with the Championship conditions.)

14. START OF A RACE

A red signal light will be displayed for up to five seconds. The red light will go out to start the race.

Or the National Flag will be lowered. All races will have clutch starts.

15. FINISH OF A RACE

The Chequered flag will be displayed as the winner crosses the finishing line. The criteria for establishing the finishing order and the number of finishers is as set out in the ACU Standing Regulations.

16. TYRES - Slick tyres are permitted for Solo classes A, C, D, G, K, & L

17. 'ANGLESEY GRAND'

The meeting on 12th & 13th October incorporates the 'Anglesey Grand'. Invitations to this will be based on known ability and on performances on 12th October.
